IT'S SUMMER – so that means our Summer Outing, which is always an enjoyable way to meet other M.V.C.G. members. Read all about it on page 7. Summer is also a good time for outdoor work, and a lot of this edition is about what's been happening in Manor Woods Valley Local Nature Reserve – again! Martin and the gang have been working hard and it shows.

They're not doing it all on their own, of course. Our regular helpers, GoodGym, have been again and will be coming back, and we've also had volunteers from the Avon Wildlife Trust and the Environment Agency. And the word gets around – the E.A. people so enjoyed the well-organised and fulfilling work that they told their colleagues and we had two e-mails from other parts of the E.A. asking to come and help.

Improving things on the ground is what M.V.C.G. has always been about, and there are direct ways of doing that and indirect ways. Often, the indirect ways mean trying to shape future plans and policies, which is the reason we spend time in meetings. It's also another aspect of our work in Manor Woods Valley and more widely. Martin's article starting on page 2 reports our application to achieve protected 'Local Green Space' status for the northern part of Manor Woods Valley which should have been included in the Local Nature Reserve in 2008 but wasn't, because it came under a different part of the City Council.

We're also working with the City Council on a Management Statement for the Orchard area of Manor Woods Valley so as to have an agreed framework for future work. Working with the City Council has always been a central principle for M.V.C.G., but it's much more difficult since the cuts reduced the staff in Bristol Parks and the time those staff have to work with us. But there are still people in Parks who are trying very hard to keep the show on the road; we appreciate that, and we want to help them as much as possible.

NEWS FROM MANOR WOODS VALLEY L.N.R.

THE EARLY SUMMER MONTHS in Manor Woods Valley have been all about 'learning'. Students from the University of Bristol completed their final report on water quality in the Malago. Students from the University of the West of England (UWE) are currently carrying out tree surveys in Manor Woods, the results of which will feature in the next *Newsletter*.

Students of the University of the Third Age (U3A) enjoyed an ecological guided tour of Manor Woods Valley Local Nature Reserve led by Peter, professional ecologist and our newest committee member. Peter also led similar tours for members of the South Bristol Gardening Club and a U3A walking group.

Students also featured among the many volunteers who have been helping to clear brambles, common hogweed and thistles in Manor Woods Orchard. We're grateful for their help and also for the hard work of other volunteers from the Environment Agency, Avon Wildlife Trust, Bristol GoodGym runners and our loyal and local supporters. The Bristol Urban Buzz Project are supporting the orchard work with advice and a donation grass and wildflower seeds. The Bristol Fish Project (based in Vale Lane) are also lending their support by providing access for our volunteers to their kitchen and toilet facilities.

The Orchard has been a great source of learning for us over the summer. Led by Peter, we have been grappling with the development of a medium- and long-term ecological and community plan for the Orchard. We are currently consulting on the draft with the Council's Parks Team. M.V.C.G. members will have an opportunity to share their views on the final draft in the coming months.

As well as direct work now and planning for future improvements, we haven't lost sight of our long-standing aim to get the same sort of permanent protection for the Orchard and the wider Old Quarries area that the main part of Manor Woods Valley enjoys as an officially designated Local Nature Reserve. The revision currently under way to the Bristol Local Plan introduces the new national classification of 'Local Green Space' – this would give similar

protection to that given to the Green Belt. We have asked for this designation to be applied to both the Orchard area and the Quarries area as a whole – that’s the land which is contiguous with the L.N.R. to the north and which extends west to Ilchester Crescent and the television transmitter mast.

The Forest of Avon Trust are continuing, over the summer months, with their very successful ‘Mindfulness’ courses in Manor Woods. Course members, from the Bristol Rehabilitation Service, learn woodland craft and cooking skills as well as identifying wild flowers, trees and birds.

PLANNING MATTERS

HERE'S A VERY QUICK UPDATE on some significant planning applications in BS13. Many of them were reported on at our A.G.M. in February.

- **131 Bridgwater Road:** the next stage in the process dealing with this planning shambles is an informal hearing on 11 July into the Appeal by the applicants against refusal of retrospective permission for what they illegally built.
- **Former Bristol Water depot near the Cross Hands:** the application to build 62 new dwellings was made in April and is currently being considered.

- **Waverley Gardens:** the application to double the size of the existing home by demolishing the former Redhouse School and extending onto that site is still pending.
- **Former Bishopsworth Police Station:** the application to build nine houses in three terraces of three has been revised and is still pending.
- **Hartcliffe Campus:** there is a major application for 350 houses on the site bounded by Hawkfield Road to the west, William Jessop Way to the south and Parkview Campus to the north and east. There are several issues here, including wildlife and habitat ones, and it has been discussed regularly at the 'Pride of Place' group who are leading on responding to the application.

PRIVACY STATEMENT

Malago Valley Conservation Group collects and uses personal information and as such is a Data Controller under the General Data Protection Regulation (GDPR). The personal data that we hold allows us to communicate with our members, volunteers and colleagues and to administer the Group; for example, to send newsletters and e-mails and to collect subscriptions. The only data we hold is name, address (business address in the case of colleagues who are not members), phone number where it has been given to us by members or colleagues, membership status, and e-mail address. In the case of volunteers who are not members, we hold names and e-mail addresses only.

Apart from the quarterly newsletters, we contact members, volunteers and colleagues very infrequently and only regarding M.V.C.G. matters when they would reasonably expect us to do so, e.g. where there is some late information to communicate.


We do not hold data for any other purpose, nor do we hold data that is not necessary for us to fulfil our obligations. We use members', volunteers' and colleagues' data in ways which, we believe, they would reasonably expect on joining the Group or requesting to receive mailings. The legal basis for holding and processing this information is 'legitimate interest' or 'consent' under GDPR.

We will not share personal data with any other person or organisation unless legally obliged to do so. We will not keep personal data for longer than necessary under the legal basis for processing or as required to fulfil statutory obligations.

SUMMER OUTING

This year's Summer Outing will be to the **FEED BRISTOL** site of the Avon Wildlife Trust. FEED BRISTOL is AWT's community food growing project where the Trust champions conservation and ecology while supporting people's wellbeing. They run a native wildflower nursery from the site so you will be able to talk to an expert about wildlife gardening and how to use wildflowers in your garden design.



FEED BRISTOL is open for anyone to visit during the week, with special open days on the first Saturday of the month. We have arranged to visit them on **SATURDAY 4 AUGUST**. We will have a guided tour, which will take about an hour and will explore the site along accessible footpaths. It will highlight how AWT are using different wildlife gardening techniques to create a place where people and nature thrive in a productive setting. The tour will start at **11.00am**, so make sure you arrive in plenty of time before then. The site is open from 9.00am to 5.00pm. After the tour, refreshments will be provided in the café.

There is no charge for the visit, but you may like to bring money to buy some of their plants for your garden. M.V.C.G. will make a donation to thank AWT for the guided tour, and you may like to make your own donation to this good cause.

FEED BRISTOL is at 181 Frenchay Park Road, Stapleton, Bristol, BS16 1HB, on the junction with Stoke Lane. Please use the parking at Begbrook Social Club, which is 50 metres past the entrance on Frenchay Park Road on the right. If people have walking difficulties they are welcome to come into the main FEED BRISTOL car park area.
